**A RESOLUTION COMMENDING THE ENTIRE MEMBERSHIP OF THE IGLESIA NI CRISTO FOR THE STAGING OF THE WORLD RECORD-SETTING HUMANITARIAN MISSION DUBBED AS "WORLD-WIDE WALK FOR A CAUSE" LAST FEBRUARY 15, FOR THE PURPOSE OF RAISING FUNDS FOR THE REHABILITATION/RECONSTRUCTION OF PROVINCES IN EASTERN AND CENTRAL VISAYAS DEVASTATED BY SUPER TYPHOON YOLANDA.**

*WHEREAS, the devastation wrought by super typhoon Yolanda in Eastern and Central Visayas will require massive rehabilitation efforts not only from both National and Local Government, but also from well-meaning sectors of our society;*

*WHEREAS, responding to the call of the times and being consistent with its well-known humanitarian thrust, the Iglesia ni Cristo mobilized its faithful members—both here and in other parts of the world—for the conduct of a "World-Wide Walk for a Cause" aimed at raising funds to support the rehabilitation efforts in the Visayas, particularly Leyte and Samar, in the aftermath of the near-cataclysmic devastation caused by super typhoon Yolanda, resulting in the loss of 6,200 lives (with more than 2,000 missing), and more than 4 million individuals left homeless;* X
