**A RESOLUTION GRANTING A SPECIAL PERMIT TO THISISIT GAMING CORPORATION TO ESTABLISH A SPORTS BAR AT PACIFIC CENTURY TOWER BUILDING, QUEZON AVENUE, BARANGAY SOUTH TRIANGLE, QUEZON CITY, FOR PURPOSES OF OPERATING A POKER GAMES, BINGO BOUTIQUE, E-GAMES STATION, INSTAWIN TERMINALS AND MEGASPORTS WORLD BETTING STATION FRANCHISED AND LICENSED WITH THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) AND PHILWEB CORPORATION (PHILWEB).**

*WHEREAS, Thisisit Gaming Corporation is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with principal office at G/F Pacific Century Tower Building, No. 1472-1476 Quezon Avenue, South Triangle, Quezon City;*

*WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) and Philweb Corporation (PHILWEB) granted Thisisit Gaming Corporation an authority to operate a sports bar where said games may be played;*

*WHEREAS, Thisisit Gaming Corporation seeks to operate a sports bar in Quezon City which will necessary need a franchise and permit from the City Council;*



WHEREAS, Thisisit Gaming Corporation is earnestly requesting the City Council to grant a Special Permit to operate a sports bar that includes the operation of a poker games, bingo boutique, E-Games Station, Instawin Terminals, and Megasports World Betting Station franchised and licensed with PAGCOR and PHILWEB;

WHEREAS, pursuant to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Council, through an ordinance, may grant franchises and issue permits and licenses.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Thisisit Gaming Corporation to establish a sports bar at Pacific Century Tower Building, Quezon Avenue, Barangay South Triangle, Quezon City, for purposes of operating a Poker Games, Bingo Boutique, E-Games Station, Instawin and Megasports World Betting Station franchised and licensed with the Philippine Amusement and Gaming Corporation (PAGCOR) and Philweb Corporation (PHILWEB).

RESOLVED, FURTHER, that Thisisit Gaming Corporation shall remit to the City Treasurer a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.

RESOLVED, FINALLY, that the authority herein granted shall be for a period of two (2) years and maybe renewed by the City Council.
