A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH HONORABLE HERBERT M. BAUTISTA, TO PURCHASE TWO (2) UNITS OF MOTOR VEHICLE INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR JESSICA CASTELO DAZA AMOUNTING TO ONE MILLION NINE HUNDRED NINETY THOUSAND PESOS (P1,990,000.00) TO BE CHARGED TO ANY AVAILABLE FUNDS OF THE SAME OFFICE.

Inginiero CESO IV, City Director of DILG for the acquisition of two (2) motor vehicle amounting to P 1,990,000.00;

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No.7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to purchase two (2) units of motor vehicle intended for monitoring of programs and projects of the Office of Councilor Jessica Castelo Daza, amounting to One Million Nine-Hundred Ninety Thousand Pesos (P1,990,000.00) to be charged to any available funds of the same office.
