RESOLUTION NO. SP 5995 , S-2714

A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE HERBERT M. BAUTISTA, TO INTER INTO A CONTRACT WITH DVK PHILIPPINES ENTERPRISES FOR THE PURCHASE OF BUSINESS REGISTRATION PLATES INTENDED FOR REGULATING AND MONITORING REGISTERED BUSINESSES IN QUEZON CITY AMOUNTING TO TWENTY-TWO MILLION FIVE HUNDRED THOUSAND PESOS (PHP22,500,000,00).

WHEREAS, pursuant to Section 455 (b) (l) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Punlanguod or pursuant to a law or ordinance;

WHEREAS, the Bids and Awards Committee bid out this project last February 10, 2014, where DVK Philippines Enterprises was declared the winning bidder;

WHEREAS, the Office of the City Mayor is requesting for an authorization to enter into a contract/agreement with DVK Philippines Enterprises, the winning bidder for the purchase of ninety thousand (90,000) pieces of business registration plates with the total amount of twenty-two million five hundred thousand pesos (PHP22,500,009,00), with the following description/specification.

BUSINESS REGISTRATION PLATE:

• Size: 5 %" x 15 %", 0.40mm thickness with four (4) colors made of galvalum steel sheets with white and gray back coating, embossed alpha numbers and borderline with QC and HB logo.

WHEREAS, the purchase of the said steel plates shall be issued to businesses registered in the city through the Eusiness Permits and Licensing Office (BPLO):

WHEREAS, granting this authorization to the city mayor will help in regulating and monitoring of legitimate businesses, thus, firther enhancing investment, trade, and commerce in Quezon City.

NOW THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSICIN ASSEMBLED, to authorize as it does hereby authorize the City Mayor. Honorable Herbert M. Bautista, to enter into a contract with DVK Philippines Enterprises, the winning bidder, for the purchase of business registration plates intended for regulating and monitoring registered businesses in Quezon City amounting to twenly-two million five hundred thousand pesos (PHP 22, 500, 000, 00).

RESOLVED, FURTHER, that a copy of this Resolution be given to the City Budget Department, City Accounting Department, Commission on Audit-Queron City Field Office, and Department of the Interior and Local Government for their information and guidance.
