A RESOLUTION AUTHORIZING THE CITY MATTOR, HONCRABLE HERBERT M. BAUTISTA, TO NEGOTIATE AND ENTER INTO A CONTRACT TO ACQUIRE ONE HUNDRED NINE (109) SQUARE METERS PORTION OF THE PROPERTY IDENTIFIED AS LOT 5-A, (LRC) PSD-172587 WITH AN AREA OF FOUR HUNDRED FIFTY FOUR (454) SQUARE METERS REGISTERED IN THE NAME OF FELICIDAD E. VILLARUZ, ET. AL. COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 004-2010004142 LOCATED AT MAGSAYSAY STREET AND THAVESSED BY GARCIA EXTENSION THAT SERVES AS THE ROAD RIGHT-OF-WAY OF ABOUT FIVE HUNDRED (500) FAMILIES WHO USED THE SAID ROAD RIGHT-OF-WAY AT BARANGAY SAN BARTOLOME, QUEZON CITY.

Bautista, to negotiate and enter into a contract to acquire One Hundred Nine (109) Square Meters portions of the property identified as Lot 5-A, (LRC) Psd-172587 with an area of Four Hundred Fifty Four (454) Square Meters registered in the name of Fulfidad Villaruz, et al., and covered by Transfer Certificate of Title Numbered 004-2010004142 located at Magazyway Street and traversed by Garcia Extension that serves as the road right-of-way at Barangay San Bartolome, Quezon City.
