A RESOLUTION DONATING ONE (I) UNIT OF AMBULANCE EACH TO BARANGAT PINAGAKAISAHAN, BARANGAT SAN ISIDRO GALAS, BARANGAT ROKAS, BARANGAT DOÑA IMEDIA, AND BARANGAT SAN VICENTE, FOR THE USE OF BERNARDO HEALTH CENTER, GALAS HEALTH CENTER, KALAYAAN HEALTH CENTER, AND SAN VICENTE HEALTH CENTER, RESPECTIVELY.

WHEREAS, public health centers are established primarily to provide basic health care services to the financially challenged residents of Quezon City;

WHEREAS, emergency cases are occasionally being brought before these health centers for immediate medical attention but full treatment cannot be given completely that to the inadequacy of specialized medical equipment in these facilities;

WHEREAS, the availability of ambulance at Bernarao Health Center, Galas Health Center, Gen. Roxas Health Center, Kalayaan Health Center, and San Vicente Health Center will be of great assistance to the residents of the barangays, more particularly during emergency situation when there is a need to transfer a patient to the nearest hospital;

WHEREAS, five (5) units of ambulances were purchased using the funds of the Office of Councilor Jesus Manuel C. Suntay to be donated each to Earangays Pinagkaisahan, San Isidro Galas, Roxas, Dona Imelaa, and San Vicente in order to assist their Health Centers for the prompt delivery of health services;

WHEREAS, to efficiently utilize the donated vehicles to the health centers, a Deed of Donation will be given to the baranzay-beneficiary transferring ownership, encumbrances, and dues, in so doing, authorizing the latter to appropriate funds for the payment of the insurance and registration from their respective budgets.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby denute one (1) unit of ambulance each to Barangay Pinagkaisahan, Barangay San Isidro Calas, Barangay Roxas, Barangay Doha Imelda, and Barangay San Ficente, for the use of Bernardo Health Center, Calas Health Center, Gen. Roxas Health Center, Kalayaan Fiealth Center, and San Vicente Health Center, respectively.

RESOLVED. FURTHER, that the ownership of the said vehicles be transferred to the recipients through a Deed of Donation.

RESOLVED, FURTHERMORE, that the recipients are hereby authorized to appropriate funds for the payment of insurance, registration, and other necessary expenses for the use of these donated vehicles.

RESOLVED, FINALLY, that copies of this Resolution, along with the Deed of Donation, be given to the Office of the City Mayor, the Office of Councilor Jesus Manuel C. Suntay, the City General Services Department, and the five (5) recipients of the ambulance for future reference.
