A RESOLUTION AUTHORIZING THE CITY MAYOR OF QUEZON CITY TO ENTER INTO A CONTRACT OR AGREEMENT WITH THE WINNING BIDDERS/CONTRACTORS FOR THE PROVISION OF SERVICES AND SUPPLIES TO BE USED IN THE PROGRAMS AND PROJECTS TO BE UNDERTAKEN IN CONNECTION WITH THE CELEBRATION FOR THE 75TH FOUNDATION ANNIVERSARY OF QUEZON CITY.

WHEREAS, Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the procurement or acquisition of supplies and services by local government units shall be made through competitive public hidding;

WHEREAS, Section 455 (b) (1) (vi) of the same Code provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf contracts or agreement upon authority of the Sangguniang Panlungsod;

WHEREAS, the Commission on Audit (COA) issued Audit Observation Memorandum 2014-11-C (2013), viting as basis the Supreme Court decision in the case of Hon. Gabriel Quisumbing v Hon. Gwendolyn F. Garcia (G.R. No. 175527), requiring the City Council to give prior authorization to the City Mayor before any expenses/disbursement charged against a lump sum appropriation can be made;

WHEREAS, the Quezon City will celebrate its 75th Founding Anniversary and, in connection with the said celebration, the City will conduct various programs and projects for its residents and guests that would entail the use for the following survices and supplies:

I. Events management;

- 2. Public celebration supplies and materials;
- 3. Services; and
- 4. Lease and rental.
