RESOLVED, FURTHER, that the ownership of the said orbit/ceiling and wall fans be transferred to the recipients through a Deed of Donation to be signed by the City Mayor, Honorable Herbert M. Bautista, the Office of Councilor Anthony Peter "Onyx" D. Crisologo as the main proponents, and the Office of the City General Services Office (CGSO) represented by Mr. Rolando P. Montiel.


