WHEREAS, there is a need to have an updated available data regarding the total population of senior citizens in Quezon City,

WHEREAS, in order that the city government will have an official and updated data on the exact number of senior citizens within its jurisdiction, it is imperative that a census and survey in each and every barangay in Quezon City be immediately conducted.

NOW. THEREFORE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to enjoin, as it does hereby enjoin all Barangays in Quezon City to conduct a survey/census in their respective jurisdiction to determine the exact number of the population of Senior Citizens in their respective barangay

RESOLVED, FURTHER, the Borangay Operation Center (BOC) is hereby directed to coordinate, supervise and monitor the activity and to ensure the involvement of all Borangay Officials pertaining to the conduct of survey and census of the exact number of senior citizens in each respective borangay.

RESOLVED, FINALLY, the Barangay Operation Center (BOC) is hereby tasked to collect the said census to be submitted to the City Council.
