WHEREAS, in Quezon City there are still some Barangays that does not have health center including Barangay Manresa in District 1;

WHEREAS, the residents of Barangay Manresa are availing of basic health services from the health center located at Barangay San Jose;

WHEREAS, the residents of Barangay Manresa can readily and effectively avail of basic health services if a health center is located within the area of the Barangay.
