BAUTISTA, TO SIGN AND ACCEPT IN BEHALF OF THE QUEZON CITY GOVERNMENT THE DEED OF DONATION AND ACCEPTANCE OF A PARCEL OF LAND DESCRIBED AS LOT 7, PCS-00-012940 (ROAD LOT) COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-339832 OF THE REGISTRY OF DEEDS OF QUEZON CITY OWNED BY HIMLAYANG PILIPINO, INC. REPRESENTED BY ITS PRESIDENT, ALBERTO M. ALBANO LOCATED AT BARANGAY PASONG TAMO, QUEZON CITY.

WHEREAS, Himlayang Pilipino, Inc., a company is the memorial park industry, with principal office and postal address at 12th Floor, Triumph Bldg., 1610 Quezon City;

WHEREAS, the Quezon City Government, a local government unit, created and existing under and by virtue of the laws of the Philippines, with principal office and postal address at Quezon City Hall Compound, Elliptical Road, Diliman, Quezon City;

WHEREAS, Himlayang Pilipino is the registered owner of a parcel of land described as Lot 7, Pcs-00-012940 (Road Lot) covered by TCT No. N-339832 of the Registry of Deeds of Quezon City, containing area of one thousand seven hundred eighty four (1,784) square meters more or less located at Barangay Pasong Tumo, Quezon City;

WHEREAS, Himlaying Pilipino, through a resolution, authorized its President, Mr. Alberto M. Albano, to execute and sign the Deed of Donation of the subject purcel of land in favor of the Local Government of Quezon City;

WHEREAS, in compliance with the provisions of PD 1216, the herein donor, represented by its President, Mr. Alberto M. Albano, hereby donates and conveys in favor of the donee, Quezon City Government represented by the Honorable City Mayor Herbert M. Bautista, the parcel of land described as Lot 7, Pcs-00-012940 (Road Lot) covered by TCT No. N-339832 of the Registry of Deeds of Quezon City containing an area of one thousand seven hundred eighty four (1,784) square meters more or less located at liarangay Pasong Tamo, Quezon City;

WHEREAS, Section 22 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "Unless otherwise provided in this Code, no contract maybe entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned."

NOW, THEREFORE

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to sign and accept in behalf of the Quezon City Government, the Deed of Donation and Acceptance of a parcel of land described as Lot 7. Pcs-00-012940 (road lot) covered by ICT No. N-339832 of the Registry of Deeds of Quezon City owned by Himlayang Pilipino Inc. represented by its President, Alberto M. Albano located at Barangay Pasong Tamo, Quezon City.
