A RESOLUTION L'ONATING ONE (I) UNIT OF ALL-PUPPOSE VEHICLE (APV) TO THE DIVISION OF CITY SCHOOLS OF QUEZON CITY.

Introduced by Councilors JESUS MANUEL C. SUNTAY and GOUOFREDO T. LIBAN II.

WHEREAS, the Division of City Schools was recognized by the Department of Education and Culture established primarily to exercise general supervision over both public and private elementary and secondary schools in Quezon City;

WHEREAS, the availability of an all-purpose vehicle at the disposal of the Division of City School of Quezon City would enable such institution to properly monitor their programs for the primary and secondary schools in Quezon City to improve their scholastic performance;

WHITEEAS, the all-purpose vehicle sought to be donated to the institution shall be purchased from the funds of the Office of Councilor Jesus Manuel C. Suntay to assist them in rendering their services to our primary and secondary educational institutions;

WHEREAS, a Deed of Donation shall be given to the Division of City Schools of Quezon City transferring the ownership, encumbrances, and dues of the said which, in so doing, authorizing them to appropriate funds for the payment of the insurance and registration of the same from their respective budgets.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby donate one (1) unit of all-purpose vehicle (APV) to the Division of City Schools of Quezon unit,

RESOLVED. FURTHER, that the ownership of the said vehicles be transferred to the recipients through a Deed of Donation, to be signed by the City Mayor, Honorable Herbert M. Bautista, Councilor Jesus Manuel C. Suntay as the main proponent, Dr. Potenciano A. Menguino representing the Division of City Schools of Quezon City, and Mr. Rolando P. Montiel representing the City General Services Department (CGSD).

RESOLVED, FURTHERMORE, that the recipient is authorized to appropriate funds for the payment of insurance and registration of the donated vehicle.

RESOLVED, FINALLY, that copies of this Resolution, along with the Deed of Donation, be given to the Office of the City Mayor, the Office of Councilor Jesus Manuel C. Suntay, the City General Services Department and the Division of City Schools of Quezon City for future reference.
