RESOLUTION NO. SP- **6024**, S-2014

**A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT OCCURRED ON DECEMBER 14, 2013 AT SAMADORES STREET CORNER LUZON AVENUE, BARANGAY MATANDANG BALARA, QUEZON CITY, COMPRISING OF TWO HUNDRED (200) FAMILIES, MORE OR LESS, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER, TO BE CHARGED AGAINST THE CALAMITY AND/OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE FUND IN THE CITY TREASURY.**

*WHEREAS, on December 14, 2013 a fire occurred at Samadores Street corner Luzon Avenue, Barangay Matandang Balara, Quezon City, comprising of two hundred (200) families, more or less;*

*WHEREAS, these unfortunate fire victims need the assistance of the City Government in the form of financial aid to defray the cost of building materials for the re-construction of their houses, purchase of foods, clothing and other necessary expenses;*

*WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowered the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following the said events";*

*WHEREAS, because of this unfortunate incident, the affected residents of the said fire incident who are presently in makeshift dwellings can only hope and pray for the early release of financial assistance from the city government.* y

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,** to urge, as it does hereby strongly urge the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance to ~~the construction of a building assigned on December 14, 2013 at Samadores Street~~ two hundred (200) families, more or less, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, to be charged against the calamity and/or emergency fund of the City Government or from any available fund in the city treasury.
