BAUTISTA, TO STAGE A FRIENDLY EXHIBITION BASKETEALL AND VOLLEYBALL GAME AND TO INVITE THE TALENTS OF THE SAID NETWORKS TO PARTICIPATE THEREAT AS PART OF THE CELEBRATION OF THE CITY'S 75TH DIAMOND ANNIVERSARY.
