RESOLUTION NO. SP. 6027 , S-2014

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO CITY AND LAND DEVELOPERS, INC., "NORTH RESIDENCES", FOR THE CONSTRUCTION OF A TWENTY SEVEN (27)-STOREY RESIDENTIAL/CONDOMINIUM WITH TWO (3) BASEMENT PARKING AND ROOF DECK LOCATED AT LOT I BLOCK B-3 EDSA CORNER LANUTAN ALLEY, BARANGAY VETERANS VILLAGE, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO SP-918, S-2000, AS AMENDED.

WHEREAS, in accordance with the provisions of Article IV, Article V. Article VI and Article VIII of Ordinance No. SF-918, S-2000, as amended, and its Implementing Rules and Regulations, an Exception is required for project to which the proposed project falls under.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Certificate of Exception as provided for in Article IV, Article V, Article VI and Article VIII, of Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulation to City and Land Developers, Inc., "North Residences" for the construction of a twenty seven (27)-storey residential/condominium with two (2) baxement parking and roof deck located at Lot 1 Block E-3 EDSA corner Lanutan Alley, Barangay Veterans Village, Quezon City, allowing deviation from the restrictions of the Quezon City Comprehensive Zoning Ordinance No. SP-918, S-2000, as amended.
