RESOLUTION NO. SP- 6030, S-2014

**A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE TO THE VICTIM OF FIRE THAT OCCURRED ON NOVEMBER 24, 2013 ALONG COMMONWEALTH AVENUE, LAURA, BARANGAY MATANDANG BALARA, QUEZON CITY, COMPRISING OF TEN (10) FAMILIES, MORE OR LESS, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER, TO BE CHARGED AGAINST THE CALAMITY AND/OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE FUND IN THE CITY TREASURY.**

*WHEREAS, on November 24, 2013 a conflagration occurred along Commonwealth Avenue, Laura, Barangay Matandang Balara, Quezon City, comprising of ten (10) families, more or less;*

*WHEREAS, Section 458 (1, iv) of the Local Government Code of 1991 empowered the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following the said events";*


*WHEREAS, the city government should extend financial assistance in order to alleviate the sad tragedy of said fire victims.*

**NOW, THEREFORE**


**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED**, to urge, as it does hereby urge the City Mayor, Honorable Herbert M. Bautista to extend financial assistance to the victims of fire that occurred on November 24, 2013 along Commonwealth Avenue, Lungsod Quezon City, comprising of ten (10) families, more or less, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, to be charged against the calamity and/or emergency fund of the City Government or from any available fund in the city treasury.

**RESOLVED, FURTHER**, that a copy of this resolution be forwarded to the Office of the City Mayor.
