*WHEREAS, firefighters are responsible for quick responses for fire prevention, suppression, investigation. They also have provisions of emergency and rescue services;*


*WHEREAS, Barangay Tandang Sora and its adjoining Barangays are thickly populated area where many houses are made of light building materials;*
