RESOLUTION NO. SP. 6052 , S-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO NEGOTIATE FOR THE ACQUISITION THROUGH PURCHASE A PARCEL OF LAND IDENTIFIED AS LOT 797-C-5, PSD-21048, COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. 106913, REGISTERED UNDER THE NAME OF BANGKO SENTRAL NG PILIPINAS. CONTAINING AN AREA OF TEN THOUSAND (10,000) SQUARE MITTERS, MORE OR LESS, LOCATED ALONG LUZON AVENUE, BARANGAY OLD BALAFA, QUELON CITY, PURPOSELY TO BE DEVELOPED INTO SOCIALIZED HOUSING PROJECT.

WHITHEAS, the Bangko Sentral ng Pilipinas (ESP) is the registered owner of a parcel of land technically described as Lot 79%-C-5, Psd-21048, covered by Transfer Certificate of Title (TCT) No. 106913 of the Registry of Deeds of Quezon City containing a gross area of 10,000 square meters, more or less, located along Luzon Avenus, Banangay Old Balara, Quezon City;

WHEREAS, the Luzon Avenue Homeowners Association of Diliman (LAHAD), Inc., a community association of more or less 250 on-site informal settlers (LIFs), had negotiated and entered into a Manuscriptum of Agreement (MOA) with BSP for the acquisition of the subject property through Community Mortgage Program (CMP), with an agreed price of Php2,640 per square meter and commitment period of five (5) years which started from the receipt of Notice of Approxil from ESP Board issued on February 5, 2009; J

WHEREAS, after the lapse of the five (5) year commitment period, LAHAD declared that they could no longer comply and fulfill their obligations and responsibilities inscribed in the MOA with BSP;

WHIREAS, to be able to realize their plight for security of tenure, the members of LAHAD have petitioned the Quezon City Government to adopt and

WHITREAS, the BSP has positively responded to the proposals of the Task Force on Socialized Housing and Development of Blighted Areas (TF Housing) to substitute (AHAD) in the acquisition of the subject property and to develop the same into Bistekville Housing Project, for the benefit of the on-site ISFs.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to negotiate for the acquisition through purchase a parcel of land identified as Lot 797-C-5, Psd-21048, covered by Transfer Certificate of Title (TCT) No. 106913, registered under the name of Bangko Sentral ng Pilipinas, containing an area of Ten Thansand (10,000) square meters, more or less, located along Luzon Avenue, Banangay Old Balara, Quenon City, purposely to be developed into socialized housing project.
