RESOLUTION NO. SP. 6055 , S-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE HERBERT M. RAUTISTA, QUEZON CITY, TO ACQUIRE THROUGH NEGOTIATED SALE A PARCEL OF LAND IDENTIFIED AS LOT 161-NEW-C-3, (LRC) PSD-2110, COVERED BY TRANSFER CERTIFICATE OF TITLE (TUT) NO. RT-82664 (35519), REGISTERED UNDER THE NAME OF SPOUSES PRECITA AND ELEAZAR RIGLANG-AWA, CONTAINING AN AREA OF FOUR THOUSAND (4,000) SQUARE METERS, MORE OR LESS, SITUATED ALONG PASACOLA STREET (SB DIVERSION ROAD), BARANGAY NAGRAISANG NAYON, NOVALICHES, QUEZON CITY, PURPOSELY TO BE DEVELOPED INTO SOCIALIZED HOUSING PROJECT.

WHEREAS, the Quezon City Task Force on Socialized Housing and Development of Blighted Areas (TF Housing), in its desire to provide greater opportunities to significant number of Quezon City informal settlers/residents to own in-city affordable and decent housing, has been releasless in its efforts to expand its socialized housing projects:

White EMEAS, the TF Housing has negotiated with the owner of the property and has more or less come up with an agreeable terms of the sale;

WhEREAS, pursuant to Section 455 (b) (1) of Kepublic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Paulungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Howorable Herbert M. Bautista, Quezon City, to acquire through negotiated rale a parcel of land identified as Lot 161-New-C-3, (LRC) PSD-2110, covered by Transfer Certificate of Title (TCT) No. RT-82664 (35519), registered under the name of Spouses Precita and Eleazar Biglang-Awa, containing an area of Four Thousand (4,000) square meters, more or less, situated clong Pasacola Street (SB Diversion Road), Barangay Nagkaisang Nayon, Nasaliches, Quezon City, purposely to be developed into socialized housing project.
