RESOLUTION NO. SP- 6056 , S-2014

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO GRANT FUNANCIAL ASSISTANCE TO THE MUNICIPALITY OF TOLOSA, LETTE, IN THE AMOUNT OF THREE MILLION TWO HUNDRED NINETY FOUR THOUSAND FIFTY SIX PESOS AND SIXTY EIGHT CENTAVOS (PHP3,294,056.68). FOR THE REHABILITATION OF THE LEGISLATIVE BUILDING DESTROYED BY TYPHOON YOLANDA (HALYAN) AND FOR THE RENTAL OF THE PAYLOADER TRUCKS, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHIREAS, on November 8, 2013, Super Typhoon Yolanda (Haiyan) devastated the Philippines, particularly the provinces of Leyte and Eastern Samar. Super Typhoon Yolanda was the strongest tropical cyclone which hit the Philippines in 2013 and was one of the most powerful ever recorded;

WHEREAS, typhoon Yolanda caused catastrophic destruction in the Visayas, about 11 million people have been affected many have been left homeless and millions of agricultural products and properties of our countrymen have been destroyed;

WHEREAS, the Municipalities of Santa Fe, Palompon, and Tolosa, all in Leyte, have been adopted by the Quezon City government following the onslaught of the typhoon: A

WHIREAS, presuent to Ordinance No. SP-2.32, S-2013 entitled, "An Ordinance establishing the guidelines for the transfer of Quezon City Disaster Risk Reduction and Management fund to other Local Disaster Risk Reduction and Management Councils which are declared under State of Calamita" this Revolution is adopted

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to grant financial assistance to the Municipality of Tolosa. Leyte, in the amount of Three Million Twenty Nine Thousand Fifty Six Pesos and Sixty Eight Centavos (Php3,029,056.68), for the rehabilitation of the Legislative Building, destroyed by Typhoon Yolanda (Haiyan), subject to existing laws, rules and regulations:

RESOLVED, FURTHER, that a copy of this Resolution be forwarded to the municipal povernment of Tolosa, Leyte for their information and reference.
