A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE IN THE AMOUNT OF FOUR MILLION FIVE HUNDRED THOUSAND PEROS (PEP4,500,000.00) TO BE USED AS MOBILE LIBRARY, FOR THE EDUCATIONAL PROGRAM OF THE OFFICE OF COUNCILOR CANDY A. MEDINA OF THE 6TH DISTRICT OF QUEZON CITY, CHARGEABLE AGAINST THE FUNDS OF THE SAID OFFICE.
