A RESOLUTION GRANTING A SPECIAL PERMIT TO BIG TIME GAMING CORPORATION TO OPERATE A BINGO HALL IN INTREPID PLAZA, LIBIS, QUEZON CITY, FOR PURPOSES OF HOLDING BINGO GAMES SUBJECT TO THE RULES AND REGULATIONS PROMUEGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION

WHEREAS, Big Time Gaming Corporation is a don extic corporation duly organized and existing under and by virtue of the knos of the Republic of the Philippine, with principal office at Intrepid Plaza, Libis, Quezon City;

WHIRIAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted Big Time Gaming Corporation, a substidiary of AB Leisure Exponent inc., an authority to operate bingo halls where said games may be played;

WHEREAS, under the provisions of Republic Act No. 7166, otherwise known as the Local Government Code of 1991, the City Council, through a Resolution, may grant Special Permits or Licenses;

WHIREAS, Big Time Gaming Corporation, through its representative Mr. Aleja dro P. Alonte, seems to operate bingo halls in Quezon City which necessarily need a Special Permit from the Quezon City Council; y

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Big Time Gaming Corporation to operate a birgo half in Intrepid Plaza, Libis, Quezon City, for purposes of holding bingo games subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation.

RESOLVED, FURTHER, if at the authority to operate a Bingo hall granted herein shall be subject to the following limitations:

- The holding of birgo halis shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- The operation of bings halls shall not include the playing of games not related to or other than bings;
- e. The operator is enjoined to prohibit individuals below 18 years of age from playing in the above-mentic ned games

RESOLVED, FURTHERMORE, that Big Time Gaming Corporation shall remit to the City Treasurer a franchise fee of three percent (3%) of the gross sales of herein grantee, which shall be made payable yearly to the City Treasurer during the lightone of this measure.

RESOLVED, FINALLY, that the authority herein granted shall be for a period of two (2) years and maybe renewed by the City Council.
