A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, QUIEZON CITY, TO ACQUIRE THROUGH DIRECT SALE A PARCIEL OF LAND IDENTIFIED AS LOT 85-A-1-C, PSD-007464-330268-D, COVERED BY TRANSFER CHROTECATE OF TITLE (TCT) NO. 105109 REGISTERED UNDER THE NAME OF G.B. FRANCISCO INC., CONTAINING AN AREA OF EIGHT HUNDRED SEVENTY SEVEN (877) SQUARE MOTERS, MORE OR LESS, SITUATED ALONG SARMIENTO STREET, HARANGAY STAL MONICA, NOVALICHES, QUEZON CITY, TO BE DEVELOPTD INTO SOCIALIZED HOUSING PROJECT.

WHEREAS, the IF Housing has negotiated with the owner of the property and has more or less come up with an agreeable terms of the sale;

WHEREAS, pursuant to Section 155 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sanggunia g Panlungsod or pursuant to law or ordinance.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, Quezon City, to acquire through direct sale a parcel of land identified as Lot 85-A-1-C, Psd-007404-030208-D, covered by Transfer Certificate of Title (TCT) No. 105109, registered under the name of G.B. Francisco Inc., containing an area of light Hundred Seventy Seven (877) square meters, more or less, situated along Sermicuto Street, Barangay Sta. Monica, Novaliches, Quezon City, to be developed into socialized housing project.
