RESOLUTION NO. SP. 6071 , S. 2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (I) UNIT OF MOTOR VEHICLE IN THE AMOUNT OF TIVE HUNDRED NINETY SIX THOUSAND PESOS (PHP596,000,00), INTENDED TO FACILITATE THE IMPLEMENTATION OF THE PROGRAMS AND PROJECTS OF THE DIVISION OF CITY SCHOOLS OF QUETON CITY TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF COUNCILOR JESUS MANUEL C. SUNTAY.
