RESOLUTION NO. SP. 6074 . 2014

A RESOLUTION GRANTING A SPECIAL PERMIT TO GALLERIA RINGO CORPORATION TO OPERATE A BINGO HALL IN SELO, L#3 ROBINSON'S GALLERIA, UGONG NORTE, QUEZON CITY FOR PURPOSES OF HOLDING BINGO GAMES SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION.

WHEREAS, Galleria Bingo Corporation is a demestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with principal office at S#10, L#3 Fobinson's Galleria, Ugong Norte, Quezon City;

WHEREAS, the Philippine Amusement and Caming Corporation (PAGCOR, granted Galleria Bingo Corporation an authority to operate bingo halls where said games may be played;

WHIREAS, under the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Council , through a Resolution, may grant Special Permits or licenses;

WHIREAS. Galleria Bingo Corporation, through its representative Ms. Alicia A. Fisos, seeks to operate bingo halls in Quezon City which necessarily need a Special Permit from the Quezon City Council;

NOW, THEREFORE

BE TRESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION, to grant, as it does hereby grant a Special Permit to Galleria Bango Corporation to operate a Bingo Hall in 1410, L#3 Robinson's Galleria Ugong Morte, Quezon City for purposes of holding Bingo games subject to the Rules and Regulations Promulgated by the Philippine Amusement and

RESOLVEL, FURTHER that the authority to operate a Bingo hall granted herein shall be subject to the following limitations:

- a. The holding of bingo games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of bings halls shall not include the playing of games not related to or other than bingo;
- c. The operator is enjoined to prohibit individuals below 18 years of age from playing in the above-mentioned games

RESCLVED. FURTHERMORE, that Galleria Bingo Corporation shall remit a franchive fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.

RESCLVED. FINALLY, that this Special Permit to operate a bingo hall shall be for a period of two (2) years.
