RESOLUTION NO SP- **6077**, S-20**14**

**A RESOLUTION AUTHORIZING THE GRANTING OF FINANCIAL ASSISTANCE TO TWENTY-FOUR (24) FAMILIES WHO WERE VICTIMS OF A FIRE THAT OCCURRED ON JANUARY 9, 2014 AT FELIX MANALO STREET, BARANGAY IMMACULATE CONCEPTION, QUEZON CITY AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER SHARER TO BE TAKEN FROM THE APPROPRIATIONS FOR GRANTS, AIDS AND SUBSIDIES OF THE OFFICE OF THE CITY MAYOR UNDER THE 2014 ANNUAL BUDGET OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.**

*WHEREAS, under Section 458 (a) (1) (iv) of the Local Government Code, of 1991 the City Council shall adopt measures to provide relief services and assistance for victims during and in the aftermath of disasters or calamities;*

*WHEREAS, on January 9, 2014, a fire razed houses at Felix Manalo Street, Barangay Immaculate Conception Quezon City that affected twenty four (24) families;*

*WHEREAS, financial assistance should be extended by the city government in order to alleviate the sad plight of fire victims.*

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the twenty four (24) families who were victims of a fire that occurred on January 9, 2014 at Felix Manalo Street, Barangay Immaculate Conception, Quezon City, at Two Thousand Pesos (P2,000.00) per house-owners and One Thousand Pesos (P1,000.00) per house renters sharers, to be taken from the appropriations for Grants, Aids and Subsidies of the Office of the City Mayor under the 2014 Annual Budget of the Quezon City Government or from any available funds of the City Government.** ✓




