A RESOLUTION AUTHORIZING THE GRANTING OF FINANCIAL ASSISTANCE TO SWENTY-FOUR (24) FAMILIES WHO WE'RE VICTIMS OF A FIRE THAT OCCURRED ON JANUARY 9, 2014 AT FELIX MANALO STREET, BARANGAY IMMACULATE CONCEPTION, QUEZON CITY AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY CONFER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER SHARER TO BE TAKEN FROM THE APPROPRIATIONS FOR GRANTS, AFOL AND SUBSIDIES OF THE OFFICE OF THE CITY MAYOR UNDER THE 2014 ANNUAL BUDGET OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

WHEREAS, under Section 458 (a) (1) (iv) of the Local Government Code, of 1991 the City Council shall adopt measures to provide relief services and assistance for victims during and in the aftermath of disasters or calamities:

WHIREAS, on January 9, 2014, a fire razed hower at Felix Manalo Street, Barangay Immaculate Conception Quezor. City that affected twenty four (24) families;

WHEREAS, strancial assistance should be extended by the city government in order to alleriate the sad flight of five victims.

## NOW, THEREFORE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the twenty four (24) families who were victims of a fire that occurred on January 9, 2014 at Felix Manado Street, Burangay Immaculate Conception, Queron City, at Two Thousand Pesos (P2,000.10) per house-owners and One Thousand Pesos (P1,000.00) per house renters sharers, to be taken from the appropriations for Grants, Aids and Subsidies of the Office of the City Mayor under the 2014 Annual Budget of the Quezon City Government or from any available junds of the City Government, y
