RESOLUTION NO. SP- 6082, S-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO UTILIZE AND DISBURSE THE AMOUNT OF FOUR HUNDRED FIFTY MILLION PESOS (PHP450,000,000.00) TO BE TAKEN FROM THE LUMP SUM APPROPRIATION (SPECIAL ACTIVITIES PROGRAM), OFFICE OF THE MAYOR, TO DEFRAY SPECIFIC EXPENSE ACTIVITIES OF THE CITY GOVERNMENT.

WHEREAS, Ordinance No. SP-2234, Series of 2013 dated 20 December 2013 authorized the City Mayor to disburse the amount of Four Hundred Fifty Million Pesos (PhP450,000,000.00) classified as the Special Activities Program of the Office of the Mayor;

WHEREAS, the Special Activities Program is meant to cover programs other than regular programs that address poverty and/or promote the welfare of city hall employees;


WHEREAS, there is a need to provide for specific programs or activities to be undertaken by the city government and the administration to be taken from the aforementioned Lump Sum appropriation;

WHEREAS, the Local Finance Committee attests that the amount of Four Hundred Fifty Million Pesos (PhP450,000,000.00) classified as the Special Activities Program of the Office of the Mayor is available for appropriation to specific programs identified and approved for implementation by the Honorable Mayor.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY, IN REGULAR SESSION ASSEMBLED, to approve, as it does hereby approve the utilization of the Special Activities Program Fund (Lump Sum Appropriation) of the Office of the Mayor, as follows:


