**A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO RAYMOND TRANSPORTATION, FOR THE OPERATION OF BUS TERMINAL LOCATED AT NO. 681 EDSA, CUBAO, QUEZON CITY.**


*WHEREAS, Raymond Transportation, through Silvino Angeles Escobar, is applying for a Special Use Permit for the operation of bus terminal located at No. 681 EDSA, Cubao, Quezon City;*

*WHEREAS, in accordance with the provisions of Article VII, Section 2 and Article IX of Ordinance No. SP-918, S-2000, and its Implementing Rules and Regulations, a Special Use Permit is required for this project;*

*WHEREAS, the petitioner has complied with the requirements for their application and that the Barangay Council of Barangay Pinagkaisahan, interposes no objection for the operation of the said bus terminal. Copy of Barangay Resolution No. 71, Series of 2014 of the said Barangay is hereto attached.*

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to Raymond Transportation, for the operation of bus terminal located at No. 681 EDSA, Cubao, Quezon City.**



*RESOLVED, FURTHER, that all Resolutions adopted by the Quezon City Council authorizing the granting of Special Use Permits for the operation of transport terminals and/or garage are hereby amended and/or modified accordingly and therefore subject to the foregoing terms and conditions.*

*RESOLVED, FURTHERMORE, that all Resolutions to be adopted by the Quezon City Council authorizing the granting of Special Use Permits for the operation of transport terminals and/or garage in Quezon City shall be subject to the foregoing terms and conditions.*

- 1. The Special Use Permit shall be automatically revoked in case the franchise to operate of the transport company is cancelled by the Land Transportation Franchising and Regulatory Board (LTFRB);*
- 2. Only public utility vehicles of the transport company shall use the transport terminal and and/or the garage. The public utility vehicles shall have the appropriate body marking of the transport company;*
- 3. Transport companies shall not park any of its public utility vehicles outside or any streets, within the vicinity of the terminal and/or garage;*
- 4. In case the transport company is sold, the new owner shall apply for a new permit to operate transport terminals and/or garage in the name of the new owner;*
- 5. The Special Use Permit to operate transport terminals and/or garage shall be automatically revoked in case the transport company ceased to operate;*
- 6. The City Council may revoke the authority for the issuance of the Special Use Permits to transport companies to operate transport terminals and/or garage in Quezon City in cases of habitual violations of traffic laws, rules and regulations committed by drivers of the transport company as recommended by the Metropolitan Manila Development Authority (MMDA), Quezon City Police District Traffic Bureau and/or of the Department of Public Order and Safety (DPOS).*

*RESOLVED, FINALLY, that the following shall be furnished with copies of this Resolution:*

- 1. The Honorable City Mayor of Quezon City*
- 2. All transport owners and/or companies granted with Special Use Permits to operated transport terminals and/or garage in Quezon City*
- 3. City Planning and Development Department*
- 4. Department of Public Order and Safety*




