REMO, JR., FOR THE CONSTRUCTION OF A TWO (2)-STOREY MOTOR REPAIR SHOP (PROTECH MOTORWORKS) LOCATED AT LOT I BLOCK 524 AGNO STREET, BARANGAY TATALON, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
