WHEREAS, Section 2 of Republic Act No. 8044 states that, "The State recognizes its responsibility to enable the youth to fulfill their vital role in nation-building and hereby establishes the National Comprehensive and Coordinated Program on Youth Development, creates the structures to implement the same and appropriates adequate funds to provide support for the program and implementing structures on a continuing, sustained basis."

WHEREAS, Section 13 of Republic Act No. 8044 further states that: "There is hereby constituted the "Youth Parliament." The Youth Parliament shall be initially convened not later than six (6) months from the full constitution of the Commission, and shall meet at the call of the National Commission, and thereafter be convened every two (2) years. The Youth Parliament shall have a regular session from two (2) to three (3) days every time it is convened, but may form task forces which may meet during the period between the convening thereof."

"Delegates to the Youth Parliament shall be chosen by the Commission taking into consideration equal and geographical representation among men and women. All delegates shall be of good moral character, able to read and write, has not been convicted of any crime involving moral turpitude, and shall not be more than thirty (30) years of age on the day of election to the position by virtue of which he qualifies as a delegate and on the day the Parliament is convened. The delegates shall elect the President of the Youth Parliament who shall preside during the session of the Youth Parliament."

WHEREAS, the 10th National Youth Parliament (NYP) was held and convened last May 15 to 19, 2014 at the Manila Grand Opera Hotel in Sta. Cruz, City of Manila;

WHEREAS, the 10th NYP was attended by Two Hundred Sixteen (216) young people, ages 15 to 30, chosen from among the applications submitted to the National Youth Commission with utmost consideration of the equal representation from ALL the Regions of the Philippines;

WHEREAS, Ms. Farahnaz Ali Ghodsinia, a resident of Barangay Tandang Sora, a proud Maranaw, applied and represented Quezon City during the 10th NYP;

WHEREAS, from among the 216 delegates, particularly those that signify their intention to lead the Parliament, Ms. Ghodsinia, the lone female candidate, was proclaimed by the National Youth Commission as the duly elected President and Presiding Officer;



WHEREAS, the 10th National Youth Parliament, through the leadershin of Ms. Fargh 4th Glovdeissian easier Complemation -an-ressay-writing contest on "How to Make the World a Better Place?",

WHEREAS, the grant of One Thousand Dollars (US\$1,000) she received will be given for her identified socio-civic project — helping the young Muslims in Mindanao;

WHEREAS, in July 2011, she was chosen as the lone Filipino representative to the 22nd International Youth Leadership Conference held in Prague, Czech Republic under the theme of "Cross-cultural exchange concerning future world leadership";

WHEREAS, she also became the Philippine-Japan Goodwill Ambassador in April 2012 through the Japan-East Asia Network of Exchange Students and Youths (JENESYS) Program of the National Youth Commission held to discuss issues on environmental sustainability and disaster management:
