A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR THE MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR FRANZ S. PUMAREN, MINORITY FLOOR LEADER OF THE 19TH CITY COUNCIL, AMOUNTING TO NINE HUNDRED EIGHTY THOUSAND PESOS (P980,000.00) TO BE CHARGED TO THE OFFICE OF THE CITY COUNCILOR.
