WHEREAS, Bistekville-2 is the second and largest of the Socialized Housing Projects being implemented by the LGU-QC Task Force on Socialized Housing and Development of Blighted Areas, consisting of One Thousand One Hundred Sixty One (1,161) residential housing units and gross subdivision area of Forty Eight Thousand Eight Hundred Seventy Six (48,876) square meters located at Barangay Kaligayahan, Novaliches, Quezon City;

WHEREAS, paragraphs (3.q) and (10) of the MOA for the development of Bistekville-2 provide that LGU-QC shall be responsible for the Estate Management of the project, as such, it shall be responsible for the preparation, promulgation, enforcement and imposition of the Deed of Restriction, House Rules and Regulations for the maintenance and management of the project; x

WHEREAS, the PPHC, the developer of the project has also agreed to provide its technical expertise, support and assistance necessary for the successful implementation of the estate management maintenance of the project.

Bautista, with the Philippine Business for Social Progress (PBSP) and Phinma Property Holding Corporation (PPHC), for the Estate Management and Maintenance of the Socialized Housing Project Bistekville-2 located at Barangay Kaligayahan, Novaliches, Quezon City.
