WHEREAS, it is the policy of the State to value the rehabilitation of the disabled, as well as their integration into the mainstream of society;

WHEREAS, under Republic Act No. 7277, otherwise known as the Magna Carta of Disabled Persons, a Person with Disability (PWD) is defined as those suffering from restriction or different abilities as a result of physical, mental, and sensory impairment, to perform an activity in the manner or range considered normal for a human being;

WHEREAS, it is the duty of the local government through the City Council, to approve legislation that shall provide for the benefit and care of disabled persons;

WHEREAS, it is imperative under the principle of Social Justice to humanize laws through the adoption of measures so that social equilibrium may be achieved;

WHEREAS, on July 20, 2009 the Quezon City Council adopted Resolution No. SP-4629, S-2009 entitled:

"A RESOLUTION URGING ALL CINEMA OPERATORS IN QUEZON CITY TO GRANT FREE CINEMA ADMISSION TO SENIOR CITIZENS OF ALL THE CITY EVERY MONDAY AND TUESDAY IN ALL ESTABLISHMENTS"

WHEREAS, the State treats Senior Citizens and PWD as similarly situated in terms of being afforded benefits and goods at an affordable cost.

NOW, THEREFORE

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge all cinema operators within Quezon City to grant free cinema admission to Persons with Disabilities (PWD) every Monday and Tuesday.


