RESOLUTION NO. SP- 6098 ..., S-2014

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR OF QUEZON CITY TO ENTER INTO A CONTRACT OR AGREEMENT WITH THE WINNING BIDDERS/CONTRACTORS FOR THE PROVISION OF SERVICES AND SUPPLIES TO BE UNDERTAKEN IN CONNECTION WITH THE CELEBRATION OF THE 75TH FOUNDATION ANNIVERSARY OF QUEZON CITY WITH A TOTAL AMOUNT OF SIXTY NINE MILLION ONE HUNDRED FORTY ONE THOUSAND ONE HUNDRED TEN PESOS (PHP69,141,110.00).

WHEREAS, Section 356 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the procurement or acquisition of supplies and services by local government units (LGUs) shall be made through competitive public bidding;

WHEREAS, Section 455 (b) (1) (vi) of the same Act provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf contracts or agreements upon authority of the Sangguniang Panlungsod;

WHEREAS, the Commission on Audit (COA) issued Audit Observation Memorandum 2014-11-C (2013), citing as basis the Supreme Court decision in the case of Hon. Gabriel Quisumbing v Hon. Gwendolyn F. Garcia (G.R. No. 175527), requiring the City Council to give prior authorization to the City Mayor hefore any expenses/disbursement charged against a lump sum appropriation can be made;
