RESOLUTION NO. SP- 6101 S-2014

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE MANILA NORTH TOLLWAYS CORPORATION (MINTC) FOR THE CONSTRUCTION OF A PEDESTRIAN FOOTBRIDGE IN THE AREA OF BALINTAWAK CLOVERLEAF TRAVERSING THE NORTH LUZON EXPRESSWAY.

WHEREAS, the existing accessible route between the Gana Compound and the Barangay Hall of Barangay Unang Sigaw and A. Bonifacio Elementary School requires that pedestrians, including school children, traverse EDSA highway itself along the Balintawak Cloverleaf;

WHEREAS, to provide the constituents safe and convenient pedestrian access, there is a need to construct a footbridge that will traverse a portion of the North Luzon Expressway;

WHEREAS, the safety of the pedestrians can be maximized by constructing such footbridge;

WHEREAS, after a series of coordination meetings between the Quezon City Government, Department of Public Works and Highways, and Manila North Tollways Corporation, the parties have agreed to enter into an agreement to define their respective duties and responsibilities in relation to the proposed construction of the footbridge;

WHEREAS, Section 455 (b) (1) (vi) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, as amended, provides that the City Mayor shall "represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance".

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista to enter into a Memorandum of Agreement (MOA) with the Department of Public Works and Highways and Manila North Tollways Corporation, for the construction of a pedestrian footbridge in the area of Balintawak Cloverleaf traversing the North Luzon Expressway.

RESOLVED, FURTHER, that a copy of the Memorandum of Agreement be attached and be made as an integral part of this resolution.
