

WHEREAS, out of 658 fire hydrants in Quezon City, 516 are still functional while the 142 are already non-operational, which needs to be maintained and/or repaired;

WHEREAS, these fire hydrants are a necessity, because having a quick access to water to put out fires will save hundreds of lives which is primarily the purpose of the installation of these fire hydrants. Fire hydrant store water and save valuable time in extinguishing the fire. Thus, they should be maintained in good condition so that they will work properly.
