RESOLUTION NO. SP- 6123, S-2014

**A RESOLUTION INTERPOSING NO OBJECTION TO THE REQUEST OF XAVIERVILLE-3 GAS STATION CORPORATION REPRESENTED HEREIN BY JOHN JERRY CATOLOS FOR A SPECIAL USE PERMIT FOR THE CONSTRUCTION AND OPERATION OF A GASLINE-FILLING STATION TO BE LOCATED AT LOT 11, BLOCK 9 XAVIERVILLE AVENUE, BARANGAY LOYOLA HEIGHTS, QUEZON CITY.**

*WHEREAS, petitioner Xavierville-3 Gas Station Corporation, a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline-filling station located at Lot 11, Block 9 Xavierville Avenue, Barangay Loyola Heights, Quezon City;*

*WHEREAS, fuel stations are among the uses that require Special Use Permit upon a authorization from the Quezon City Council pursuant to Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;*

*WHEREAS, Xavierville-3 Gas Station Corporation has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned Quezon City Comprehensive Zoning Ordinance;*

*WHEREAS, the construction and operation of a gas station will provide employment and promote economic development in the City. }*
