A RESOLUTION URGING MAYNILAD WATER SERVICES, INC. TO PROVIDE WATER DISTRIBUTION AND OR INSTALLATION OF WATER FACILITIES TO THE RESIDENTS OF HILLTOP NOVALICHES SUBDIVISION, BARANGAY LAGRO, QUEZON CITY CONSISTENT WITH THE GENERAL WELFARE CLAUSE OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, in response to the request of Hilltop Novaliches Subdivision Homeowner's Association and the residents therein, there is an imperative need to consider the feasibility of requesting Maynilad Water Services, Inc. for the installation of water facilities in the area.
