RESOLUTION NO. SP. 6136 S-2014

A RESOLUTION GRANTING A SPECIAL PERMIT TO POCKET ACES GAME DEPOT TO OPERATE A SPORTSBAR, E-BINGO, INSTAWIN AND MEGASPORTS WORLD BETTING STATION LOCATED AT 100 K TOWER, NO. 100 KAMIAS ROAD, BARANGAY EAST KAMIAS, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY PHILIPPINE AMUSEMENT AND GAMING CORPORATION.

WHEREAS, Pocket Aces Game Depot, a didy registered entity, is applying for a Special Permit from the City Council as a condition precedent for the issuance of Business Permit to operate a Sportsbar, Electronic Bingo or E-Bingo, Instawin and Megasports World Betting Station pursuant to Resolution No. SP-1705, S-2001 and SP-4119, S-2008;

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted Pocket Aces Game Depot an authority to operate a Sportsbar and Electronic Bingo or E-Bingo, Instawin and Megasports World Betting Station at 100 K Tower, No. 100 Kamias Road, East Kamias, Quezon City;

WHEREAS, Barangay East Kamias issued a Barangay Clearance to Pocket Aces Game Depot to operate a Sportsbar, Electronic Bingo or E-Bingo, Instawin and Megasports World Betting Station;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the City Council to enact ordinances, issue permits and grant franchise within its jurisdiction.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special and Megasports World Betting Station located at 100 K Tower, No. 100 Kamias Road, Barangay East Kamias, Quezon City, subject to the rules and regulations promulgated by Philippine Amusement and Gaming Corporation.

RESOLVED, FURTHER, that Pocket Aces Game Depot shall remit to the City treasurer a franchise fee of three percent (3%) of the gross sales of herein grantee which shall be made payable to the City Treasurer during the lifetime of this measure.

RESOLVED, FINALLY, that the authority herein granted shall be for a period of two (2) years only; which however, it may be renewed by the City Council.
