A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO GRANT FINANCIAL ASSISTANCE TO THE CITY OF SAN JOSE DEL MONTE, BULACAN, FOR THEIR INFRASTRUCTURE PROJECT FOR THE BENEFIT OF THEIR RESIDENTS INCLUDING THE RELOCATEES FROM QUEZON CITY.

WHEREAS, in order to attain this policy of the city government, there is a need to give support to the City of San Jose Del Monte to give financial assistance for their infrastructure project which will benefit their residents including our own constituents who were relocated from our city to different nearby cities including the City of San Jose del Monte;

Code of 1991 states that "inter-local government loans, grants and subsidies-provinces, cities and municipalities may, upon approval of the majority of all members of the Sanggunian concerned and in the amount not exceeding their surplus funds, extend loans, grants, subsidies to other local government units under such terms and conditions as me be agreed by the contracting parties.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Herbert M. Bautista to grant financial assistance to the City of San Jose Del Monte, Bulacan, for their infrastructure project for the benefit of their residents including the relocatees from Quezon City.
