WHEREAS, disaster preparedness and mitigation are shared responsibilities of both the government and the communities;

WHEREAS, pursuant to the provisions of Republic Act No. 10121, Barangay officials are the primary responders during calamities or disasters since they are the government officials within the area affected by disasters or calamities;

WHEREAS, barangay officials should build up and strengthen their respective disaster preparedness and mitigation measures. They should not depend on the national government and should take pro-active measures to intensify their preparations against disasters and calamities;

WHEREAS, barangay officials should identify the hazard areas in their locality as well as the number of residents who will be directly affected by disasters and calamities, and the appropriate actions to address adverse effects thereof;


WHEREAS, even before Typhoon Glenda hits Quezon City, Barangay officials of District 6 of Quezon City immediately mobilized their disaster risk reduction personnel and put in place all necessary equipment and materials needed to mitigate the effect of Typhoon Glenda in their areas of responsibilities;

WHEREAS, due to their preparedness, the barangay officials of District 6 of Quezon City were able to immediately respond to critical areas and assist its residents affected by the onslaught of Typhoon Glenda.


