RESOLUTION NO. SP- 6148 , S-2014

A RESOLUTION STRONGLY CONDEMNING THE CRUEL KILLING OF GUILLO CESAR SERVANDO, A STUDENT OF DE LA SALLE-COLLEGE OF ST. BENILDE (DLS-CSB), COMMITTED LAST JUNE 28, 2014, IN THE CITY OF MAKATI, AND URGING THE PHILIPPINE NATIONAL POLICE (PNP) AND THE NATIONAL BUREAU OF INVESTIGATION (NBI) TO HASTEN THEIR INVESTIGATION FOR THE IMMEDIATE ARREST AND EVENTUAL PROSECUTION OF THE SUSPECTS.

WHEREAS, in the evening of June 28, 2014, eighteen (18) years old Guillo Cesar Servando was found unconscious, along with three other companions in a condominium unit at One Archer's Place in Taft, Manila;

WHEREAS, the investigation revealed that in the afternoon of June 28, 2014, Mr. Servando and his three other companions were brought to an undisclosed place in Barangay Palanan, Makati City, for their initiation rites in a fraternity and were taken to a condominium unit in Taft, Manila in the evening of the same day;

WHEREAS, at around 9:30 p.m., Mr. Servando allegedly fell on the floor unconscious which prompted his three companions to call the Philippine Red Cross. The rescue team unfortunately was unable to revive the second-year BS Hotel, Restaurant and Institution Management student.

WHEREAS, Guillo Cesar Servando was reportedly known as a loving son, a dedicated student, and a good friend, but his promising life was immediately taken because of the reported fraternity-related violence;

WHEREAS, the infliction of physical and mental abuse as a requirement in order to become a member of a fraternity, or any organization for that matter, is not consistent with the true concept and meaning of brotherhood;

WHEREAS, it is imperative that such barbaric act be condemned and that a swift and decisive resolution of this case he made by the concerned authorities in order to bring justice for Guillo Cesar Servando and his family, and to put the perpetrators of this heinous crime in jail.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to condemn, as it does hereby strongly condemn the cruel killing of Guillo Cesar Servando, a student of De La Salle-College of St. Benilde (DLS-CSB), committed last June 28, 2014, in the City of Makati and urging the Philippine National Police (PNP) and the National Bureau of Investigation (NBI) to hasten their investigation for the immediate arrest and the eventual prosecution of the suspects.
