A RESOLUTION RATIFYING THE CONTRACT OR AGREEMENT ENTERED INTO BY THE HONORABLE MAYOR OF QUEZON CITY WITH THE WINNING BIDDERS CONTRACTORS FOR THE PROVISION OF SERVICES AND SUPPLIES TO BE USED IN THE ALAY LAKAD NG MGA NAKATATANDA PROGRAMS, MEDICAL MISSION AND HEALTH RISK SCREENING AND MANAGEMENT. TO BE UNDERTAKEN IN CONNECTION WITH THE CELEBRATION OF THE 75TH FOUNDATION ANNIVERSARY OF QUEZON CITY WITH A TOTAL AMOUNT OF TWENTY TWO MILLION FIVE HUNDRED TWENTY EIGHT THOUSAND NINE HUNDRED THIRTY PESOS (PHP22,528,930.00) PURSUANT TO THE PROVISIONS OF THE CITY'S GENERAL APPROPRIATION ORDINANCE OF 2014.
