A RESOLUTION RATIFYING THE CONTRACT OR AGREEMENT ENTERED INTO BY THE HONORABLE MAYOR OF QUEZON CITY WITH THE WINNING BIDDERS/CONTRACTORS FOR THE PROVISION OF SERVICES AND SUPPLIES UNDERTAKEN DURING THE CELEBRATION OF THE 75TH FOUNDATION ANNIVERSARY OF QUEZON CITY WITH A TOTAL AMOUNT OF FORTY ONE MILLION TWO HUNDRED SEVENTY SIX THOUSAND : TWELVEPESOS AND THIRTY *EIGHT* CENTAVOS (PHP41,276,012.38) **PURSUANT** CITY'STOTHE **GENERAL** APPROPRIATION ORDINANCE OF 2014.
