A RESOLUTION RATIFYING THE CONTRACT OR AGREEMENT ENTERED BY THE HONORABLE MAYOR OF QUEZON CITY WITH THE WINNING BIDDERS CONTRACTORS. FOR THE PROVISION OF SERVICES AND SUPPLIES UNDERTAKEN DURING THE CELEBRATION OF THE 75TH FOUNDATION ANNIVERSARY OF QUEZON CITY WITH A TOTAL AMOUNT OF TWENTY SEVEN MILLION SIX HUNDRED THIRTY THOUSAND FIVE HUNDRED NINETY FIVE PESOS AND NINETY FIVE CENTAVOS (P27.630,595.95) PURSUANT TO THE CITY'S GENERAL APPROPRIATION ORDINANCE OF 2014.
