A RESOLUTION AMENDING QUEZON CITY COUNCIL RESOLUTION NO. SP-5939 S-2014, REVISING THE SPECIFICATIONS OF TWO (2) UNITS OF MOTOR VEHICLES INTENDED FOR THE MONITORING OF PROJECTS AND PROGRAMS OF THE OFFICE OF COUNCILOR JOSE A. VISAYA AND TO PROVIDE ALLOCATIONS AMOUNTING TO ONE MILLION NINE HUNDRED NINETY THOUSAND PESOS (P1,990,000.00).

BAUTISTA, TO PURCHASE TWO (2) UNITS OF MOTOR VEHICLES INTENDED FOR THE MONITORING OF PROJECTS AND PROGRAMS OF THE OFFICE OF COUNCILOR JOSE A. VISAYA TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE SAME OFFICE";

WHEREAS, the specifications of the motor vehicles did not conform to the motor vehicles intended to be purchased;
