A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO AXEIA DEVELOPMENT CORPORATION, FOR THE CONSTRUCTION OF A TEN (10)-STOREY COMMERCIAL RESIDENTIAL CONDOMINIUM BUILDING WITH BASEMENT AND SECOND FLOOR PARKING, LOCATED AT LOT 3 BLOCK 128 KALAYAAN AVENUE, BARANGAY PINYAHAN, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.
