A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE TWO (2) UNITS OF MOTOR VEHICLES IN THE AMOUNT OF ONE MILLION ONE HUNDRED NINETY TWO THOUSAND PESOS (PHP1,192,000,00), INTENDED TO FACILITATE THE IMPLEMENTION OF THE PROGRAMS AND PROJECTS OF COUNCILOR JESUS MANUEL C. SUNTAY, TO BE CHARGED AGAINST THE FUNDS OF THE OFFICE OF COUNCILOR JESUS MANUEL C. SUNTAY.

WHEREAS, the Office of Conneilor Jesus Manuel C. Suntay desires to procure two (2) units of All. Purpose Vehicle (APV) GA to be used for the aforesaid purposes, with the following general specification:

Suntay.
