WHEREAS, Belaggio Amusement Games and Arcade Park Corporation, herein referred to as Belaggio, is a corporation formed and registered under Philippine laws, and with a business address at 2F Pioneer Center Parking Building, Pioneer corner United Streets, Kapitolyo, Pasig City;

WHEREAS, the Philippine Amusement and Gaming Corporation, on 30 January 2014, has issued an Authority to Operate in favor of Belaggio;

WHEREAS, Section 458 of Republic Act 7160 provides that;

"(a) The Sangguniang Panlungsod as the Existative body of the city, shall enact ordinances, approve resolutions, and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code and shall;

(3) Subject to the provisions of Book II of this Code, exact ordinances granting franchises and authorizing the issuance of permits or licenses, upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the city xxx",

WHEREAS, Belaggio is applying for a Special Permit to establish, install, maintain, and operate an E-Bingo Boutique at Fisher Mall, Quezon Avenue, Quezon City;

WHEREAS, Belaggio is entitled to the Issuance of a Special Permit in its favor provided that the same has complied and continues to comply with all other requirements pursuant to law and other existing rules.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, us it alies hereby grant a Special Permit to Belaggio Amusement Games and Arcade Park Corporation to operate an E-Bingo Boutique at Fisher Mall, Quezon Avenue, Quezon City.
